Discuss and take appropriate action to approve recommended changes to Chapter 2, Section 9 *Employment - Demotion*, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. (Time of Recording 01:24/56:38)

On this day, on motion of Commissioner Gallardo, seconded by Commissioner Williams, it is the order of the Commission to approve the recommended changes to Chapter 2, Section 9 Employment - Demotion, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis of proposed changes to identify whether it's a disciplinary demotion or a voluntary demotion to determine what step or pay will the employee be placed in order for the policy to be clearer. Chair Acosta asked, "if there were any problems in the past with the policy". Ludy, provided response to the board that it has come across when we had followed the County's policy and even then it wasn't clear. Commissioner Gallardo asked Holly Lytle, "If she felt comfortable with this policy". Commissioner Williams, also asked Holly Lytle "If there had been any grievances filed due to this policy". After Holly Lytle from County Attorney's office responded to the board's concerns and briefly explained that due to the old verbiage under the County policy it was not clear when placing an employee in the right step according to the years of service, and drafted the policy in order to be fair, the motion carried by majority vote of the commission.

On this day, on motion of Commissioner Williams seconded by Commissioner Gallardo, it is the order of the commission to approve the recommended changes to Chapter 5, Section 2 Leave Policies - Sick Leave, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis when someone is calling in for three days or more required to provide a doctor's note. Same rule applies under FMLA. Holly Lytle from County Attorney's office briefly explained there was no significant change as there has always been the three day rule as it's mainly to match changes with the County's policy to include eliminating only accepting doctor's note from a licensed physician in the United States and accept a note from a licensed physician from another state, the motion carried by majority vote of the commission.

On this day, on motion of Commissioner Gallardo seconded by Commissioner Williams, it is the order of the commission to approve the recommended changes to Chapter 5, Section 8 Leave Policies - Holidays, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis and the significant changes to include:

1) post of the holidays 2) clarify as to what day should be taken when a holiday falls on a weekend 3) to be clearer on employees that work the shift schedule 4) for the policy to be clearer on the holiday pay. Holly Lytle from County Attorney's office responded to the board's concerns and briefly explained the policy again to incorporate the language with the County. Commissioner Acosta feels that it's important to make this changes and clarify to make sure that it's laid out, the motion carried by majority vote of the commission.

On this day, on motion of Commissioner Williams seconded by Commissioner Gallardo, it is the order of the commission to approve the recommended changes to Chapter 5, Section 9 Leave Policies - Leave Without Pay, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis and the significant changes to include: 1) to be clearer to ensure that any leave without pay is up to the discretion of the Sheriff. Commissioner Williams asked, "If leave without pay would be going to school, etc." Commissioner Gallardo asked, "If they can extend their pay without leave after their FMLA has been exhausted". Holly Lytle responded to the board's concerns and briefly explained the policy not to exceed the 90 days in addition to any leave and gives the Sheriff additional discretion to the employees, the motion carried by majority vote of the commission.

On this day, on motion of Commissioner Williams seconded by Commissioner Gallardo, it is the order of the commission to approve the recommended changes to Chapter 11, Section 3 *Promotional Procedures - Selection to Deputy Sheriff*, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis and the significant changes to include: 1) under section 11.3.07 remove the language "and employed for at least five consecutive years with a law enforcement agency and employing at least fifty peace officers" 2) this will allow the Sheriff to hire lateral transfer from other Counties.

Holly Lytle from County Attorney's office briefly explained the policy to be able to give the Sheriff the right to hire with a lateral. Assistant Chief Tom Whitten briefly explained to the commission the process on the transfers, and have the authority to hire from small Counties, the motion carried by majority vote of the commission.
